1 **ANNOUNCEMENT:**

Wayville Speedway Promotions hereafter called the PROMOTER will conduct a STADIUMCROSS for Motocross Solo Juniors & Seniors plus Senior Quads & Freestyle.

2 **JURISDICTION:**

2.1 The above mentioned meeting has been authorized by Motorcycling South Australia inc. which has issued MSA Permit No: C10001 & the event is open to holders of current Motorcycling Australia Junior & Senior National Licences.

2.2 This meeting will be held in accordance with the current General Competition Rules, these Supplementary Regulations & any final instructions by the Promoter or Motorcycling South Australia Inc.

3 **ENTRIES:**

3.1 Entries open forthwith & close last mail **23rd December, 2009**, however entries may be accepted up to five (5) days (28th Dec 2009) prior to the event but with the penalty of **\$80.00 PER RIDER (To be paid with Entry Fee)**. If not paid in full entry will not be accepted. Stamped self addresses envelope required for passes, no envelope no passes will be allocated, no passes no free entry to venue or pits.

Under no circumstances will any entries be accepted after this final date or on the day. Incomplete or late entries will not be accepted & will be returned to the Entrant. To be eligible for a refund you must notify the Race Secretary before the event & have a legitimate reason. **NO EXCEPTIONS.** Any rider refunds will be at the discretion of the Promoter & if accepted, will be posted after the event.

4 **INSURANCE:**

4.1 National Personal Accident Scheme provides basic cover for death & permanent disability.

4.2 Ambulance Insurance is compulsory for licensees.

4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

9 **ENTRIES TO CONSTITUTE A CLASS:**

Minimum will be 10 riders per class. The Promoter also reserves the right to refuse or cancel entries at any time, abandon the meeting, combine or cancel classes plus alter the program to suit entries and/or conditions on the day. Any rider refunds will be at the discretion of the Promoter (as per item no. 3).

10 **RIDING NUMBERS:**

10.1 All riders (BOTH JUNIOR & SENIOR) must display their correct & legible numbers on all three plates on their machines & also on the back of their jersey or armour.

10.2 All number plates MUST comply with the current GCR'S.

****Where heats are required, there will be 5 minutes practice followed by 5 mins timed qualifying for all riders. The top 20 lap times will proceed into 3 races, the remainder will go to a 3 race constalation .**

****The top 8 place getters from the A Grade All powers, 4 top riders from each of the B Grade All Powers & C grade Lites & Open will combine for a 15 lap Main Event Feature which will be the final race of the evening –Overall prize money plus 1st rider in each class prize money**
This event will be peg pick for gate position.**

12 **MACHINES & RIDERS:**

- 12.1 All machines entered must comply with the current GCR's for Motocross competition.
- 12.2 Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3 Change of machine may be permitted up to 10 minutes prior to the start of the event in which the substitute machine is required, provided that a change of machine notice is given & such approval given by the Clerk of Course. The substitute machine must have also been passed at machine examination.
- 12.4 Junior log books **MUST** be produced at sign on and will be kept for the duration of the event. They can be collected at the Speedway Office after the event.

13 **GRID POSITIONS:**

Grid positions for the first race will be by peg pick, subsequent choice will be by finishing order of your prior race. Heats, if more than a full gate of riders are received heats will be by peg pick with the qualifiers and non qualifiers events being determined by finishing order of the timed heats.

14 **RIDER'S BRIEFING:**

A rider's briefing will be held prior to the commencement of racing which **ALL COMPETITORS MUST ATTEND** . Any rider not attending will **not be permitted** to proceed in the event.

PITS NO RIDING ON EITHER 2 or 4 WHEELS , \$50 fine will be inforced. Extra pit passes may be purchased at gate at \$5 per person.

15 **DRUG & ALCOHOL TESTING:**

- 15.1 All competitors, mechanics & officials are advised that as part of the MA & MSA drug education program, drug testing may take place at any competition in accordance with the Australian Sports Commission policy as implemented by the Australian Sports Drug Agency & the Motorcycling SA Drug & Alcohol policy.
- 15.2 If any doubts exist over banned substances it is recommended that competitors contact the Drugs in Sport Hotline – telephone 1800 020 506. If drug testing takes place, the payment of prizemoney may be delayed at the MSA discretion until the results of the tests are known.
- 15.3 For the purposes of Drug & Alcohol testing, the commencement of the meeting will be deemed to be 8.00am with the completion of the meeting for the participant being when the participant has vacated the venue.

16 **CODE OF CONDUCT:**

All competitors, mechanics, officials, parents and guests are reminded of the MA by-law CODE OF CONDUCT as stipulated in the GCR's, which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting & will be enforced if warranted. A rider is responsible for the behaviour of any associated persons in the pit area at the event.

17 **CIRCUIT DESCRIPTION:**

The track consists of man made jumps, drop offs, banked curves, straights & table tops.

18 **STARTS:**

20 gate drop back gate with 15 & 5 second board.

20 **PRACTICE:**

ALL COMPETITORS MUST PARTICIPATE IN PRACTICE.

All competitors will be given one round of 8 minutes of practice unless altered by the Clerk of Course.

1st Lap of practice WILL be under YELLOW FLAG.

21 **NOISE: A reminder to all riders that the decibel levels have been lowered to 96db.**

Competitor's machines may be required to undergo static noise testing before commencing practice and/or any time during practice or competition. Machines not complying with these limits will be excluded from taking part in any further practice or competition.

22 **GST:**

The Goods & Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare that the sport is a hobby, the Promoter must withhold 48.5% of prizemoney over \$75 which is otherwise payable to you. Please tick one of the boxes on the Entry Form & if appropriate provide your ABN.

23 **SPECIAL NOTES & WARNINGS:**

23.1 **Open toed shoes/sandals/thongs ARE NOT permitted in the pit area for Insurance reasons & will be enforced at this event – PLEASE ADVISE YOUR FAMILY & FRIENDS etc.**

23.2 **Riding in the Pits on 2 or 4 wheels is not prohibited & WILL incur a fine of \$50.**

23.3 **Alcohol is not permitted in the pit area.**

23.4 **Mechanics must be suitably attired. This is the responsibility of the rider.**

23.5 **Dumping of fuel or oil on the ground is prohibited. Drums will be supplied for this purpose.**

23.6 **Fuel testing could occur at any time during this event**

23.7 **Animals are not permitted on the property. Guide dogs excepted.**

24 **TRANSPONDERS:**

Electronic Timing will be used for this event. It is compulsory to use the Transponders provided by Revolution Timing. A different transponder will be allocated for each bike.

- a. Transponders are the Rider's responsibility. Any loss or damage will be charged for.
- b. It is the Rider's responsibility to ensure the transponder is mounted properly and securely to prevent damage from fouling other components on the machine. Cable ties will be provided.
- c. It is the Rider's responsibility that transponders are returned in good condition at the end of the event, or if due to machine failure or injury, before the machine leaves the pit area.
- d. Transponders must be picked up and returned to the designated person/s. A Competitor's MA licence will be held by this person/s and returned in exchange for the allocated transponder. MSA will **not** re-issue or renew any licence of any person until the transponder is returned and/or all outstanding fees are paid. MSA will also enforce payment of any costs or fees.
- e. For transponders not returned on the same day, or not returned to the designated person/s, the Hirer is responsible for the transponder until it arrives back at the designated place. Revolution Timing, 68 Dawkins Road, LEWISTON SA 5501. This includes while in transit with Australia Post and by courier. No excuse will be entertained for non delivery. It is recommended transponders be hand delivered. If returning by courier or hand delivery, please ring Shannon first – 0419 008 895.
- f. Transponders **MUST** be fitted for all practice sessions

NOTE: The onus is on the Guardian/Rider to ensure the correct transponders are on the correct bikes prior to each event.

PARTICIPANT DECLARATION
CONTRACT TO PARTICIPATE IN THE STADIUMCROSS

WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS, PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.

1. I THE UNDERSIGNED (see below): [Insert Name]

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

2. In this declaration:

- a) "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
c) "MA" means Motorcycling Australia Limited;
d) "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
f) "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

3. I ACKNOWLEDGE that:

- a) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
i) that I may be injured, physically or mentally, and may be killed;
ii) that my machinery or equipment may be damaged, lost or destroyed;
iii) that competitors may ride dangerously or with a lack of skill;
iv) that track or event conditions may be hazardous and may vary without warning or predictability;
v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
vi) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
vii) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
viii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
b) the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
d) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

4. Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:
- rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees.

INDEMNITY AND RELEASE GIVEN TO ORGANISERS

5. IN CONSIDERATION of the acceptance of me as a participant in the Meeting:

- a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnitees and each of them in the following manner:
i) that I participate in the meeting at my sole risk and responsibility;
ii) that I accept the Venue as it stands with all or any defects hidden or exposed;
iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
b) I AGREE TO RELEASE to the full extent permitted by law the Indemnitees and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arises as a result of any act, matter or thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.

6. The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.

7. A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

MEDICAL

8. I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

9. I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is

compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

PRIVACY

10. I hereby consent to the collection of my personal information by the WAYVILLE SPEEDWAY PROMOTIONS, MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by WAYVILLE SPEEDWAY PROMOTIONS and MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. I understand that I may gain access to my personal information held by WAYVILLE SPEEDWAY PROMOTIONS by contacting WAYVILLE SPEEDWAY PROMOTIONS at PO BOX 210, BLACKWOOD SA or MA at 147 Montague St, South Melbourne, Victoria, 3205. I understand that if I do not provide the personal information requested above that I may not be permitted to participate in the Event.

PERSONAL HEALTH INFORMATION

11. I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

a) I ACKNOWLEDGE that:

- i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organizers and facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and
iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).
b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:
i) may collect and store any of my Information, including obtain my Information from third parties including my Carers; may use any information collected in accordance with this clause for any purpose consistent with creating safer competition in motorcycle sport and events held by or in conjunction with MA, my SCB, or with an MA or SCB permit;
ii) may disclose my Information to third parties provided such disclosure is reasonably intended to be used for the purpose of improving safety at events held by or in conjunction with MA, or with an MA permit provided any such information is held by MA or my SCB in accordance with the MA Privacy Policy.
c) I irrevocably authorise MA and my SCB and hereby appoint MA and my SCB as my lawful attorneys to collect from my Carers, and I hereby direct my Carers to provide to MA or my SCB upon request being made by MA or my SCB, any of my Information including but not limited to any information concerning any incident or event causing or contributing to or resulting from any injury, illness or death to me, the details of any diagnosis and prognosis provided to me by my Carers (or any party with the knowledge of any of my Carers), and any other matter to the knowledge of my Carers that might reasonably be considered to be requested by MA or my SCB for the purpose of improving safety at MA and SCB events.

POLICIES AND REGULATIONS

12. I acknowledge, understand and agree that it is a condition of my participation in the Event that I agree to be bound by, and subject to, the rules, regulations and jurisdiction of MA as amended from time to time. Copies of all MA rules, policies and regulations are available by contacting the MA office.

13. All participants are bound by the MA anti doping policy and thus understand they may be subject to drug testing. Testing conducted by the Australian Sports Anti-Doping Authority (ASADA) is in accordance with the ASADA Act and the National Anti-Doping Scheme. This involves the taking of a sample (an human biological fluid or tissue whether alive or otherwise, or any human breath) for the purpose of detecting the use of a Prohibited Drug or Doping Method. Any participant infringing MA's policy or refusing a drug test may be disqualified or otherwise dealt with in accordance with the terms of the anti-doping policy.
